OFFICE ORDER

Subject: Reimbursement of life saving instruments to the regular employees of the institute.

The competent authority, vide note dated 04 April 2019, has approved the procedure and rates for reimbursement of various equipment/accessories (Implants and Domiciliary equipment) as per the Central Government Health Scheme norms (CGHS) to regular employees of the institute. The procedure for reimbursement and the prevailing CGHS rates are annexed to this document.

Procedure for Reimbursement

- 1) Referral of Medical Officer of the Health Centre, IIT Kanpur for the concerned specialist of Govt. Hospital for his/her recommendation.
- 2) On the basis of the recommendation of treating Specialist at the Govt. Hospital, the Head, Health Centre will approve purchase of the equipment.
- 3) Reimbursement will be made as per the CGHS norms (mentioned below/attached as Annexures).
- 4) After procurement, the bills in original has to be submitted to the Health Centre for stock entry and other formalities.
- 5) Cost of maintenance shall be borne by the beneficiary concerned. This cost shall NOT be reimbursed.
- 6) Replacement may be permitted only after five years from the date of initial purchase, on the basis of a certificate of condemnation from the treating specialist at the Govt. Hospital.
